RULES AND REGULATIONS FOR PURCHASE OF VEHICLES BY NON-DEALERS

THERE WILL BE A 5% CHARGE ADDED TO THE TOTAL COST OF THE CAR WHEN PAYMENT METHOD USED IS OTHER THAN CASH OR CERTIFIED CHECK.

This agreement will outline the terms and conditions, which you, as a bidder, must follow in connection with bidding for the purchase of any vehicle at Augusta Auto Auction (a.k.a. 'the Auction'). You ("Bidder") agree to the following terms and conditions:

1. Bidder must complete and return to Augusta Auto Auction a signed copy of these Rules and Regulations together with a \$10.00 non-refundable transaction fee in order to purchase and participate in this auction. (WE DO NOT ACCEPT CHECKS OR CREDIT CARDS FOR THIS FEE).
2. Bidder agrees that if he/she is the successful bidder, Bidder will make payment for the vehicle to the Auction in the form of cash, cashier's check or money order unless other arrangements have been made with the Auction. Personal and business checks may be accepted if approved by TeleCheck. All checks are subject to an additional charge of five (5%) percent. Bidder will be responsible for the 5% charge even if TeleCheck does not approve Bidder's check. TeleCheck will not approve checks in excess of \$5,000.00. Failure to promptly pay in full for any vehicle purchased before the close of business will automatically result in a FORFEITURE of any deposit to the Auction. Bidder will be liable for any bids made by someone else using Bidder's credentials.
3. Bidder acknowledges receipt of a copy of Augusta Auto Auction's general rules and policies, its arbitration policy, and its light system rules and bidder agree to abide by the terms and conditions contained therein. It is your responsibility to become aware of all disclosures made at the time of sale before placing your bids. We will not arbitrate defects visible from the block or announced conditions.
4. ODOMETER READING: Bidder understands that the Auction makes no representation and does not guarantee the mileage on any vehicle purchased. Unless announced otherwise, all vehicles 10 years or older are sold "miles exempt" and Bidder understands that he/she shall not place any reliance what so ever upon the odometer reading.
5. Bidder understands that vehicles purchased may not be removed until payment has been made in full. Further, Bidder understands that vehicles must be removed from the auction by close of business Friday. Failure to do so will subject the vehicle to incurring daily storage charges at the Bidder's expense.
6. VEHICLES DAMAGED ON THE PREMISES – Buyers and Sellers expressly release the Augusta Auto Auction, Inc., and its agents, employees and principals, from any liability for any damage done to any vehicle in the care and control of the Auction. Both Buyer and Seller acknowledge that this Auction carries no insurance on any vehicles on the premises and disclaims any liability for loss from fire, theft, acts of God, or any other causes. All vehicles are left on the Auction premises at the owner's request and risk.
7. TITLE ATTACHED (TA) SALES: Bidder understands that in title attached sales the seller has 30 days to deliver the title to the Auction. If the title is not received by Augusta Auto Auction within 30 days, bidder may return the vehicle for "no title". Bidders are cautioned not to spend money on, sell, or offer for sale any vehicles purchased until title is received. The Auction will not pay expenses, including but not limited to transportation, resale or repair loss on vehicles returned for "no title". Successful Bidder must pick up and sign for title in person at Augusta Auto Auction. Bidder may have title delivered by certified mail upon payment of additional \$5.00 fee for postage and handling.

8. Off the Block Sales or Sold Outside of Sale (SOS) – are considered strictly “AS-IS”. Any guarantees are between the buyer and seller only. SOS sales are not arbitratable for ANY REASON.

9. The Auction reserves the right to interpret, apply or waive these rules and regulations at its discretion and according to the circumstances of each transaction. The Auction also reserves the right to refuse or revoke a gate pass and deny admission to anyone for causes at the auction's discretion.

10. Bidder understands and agrees to pay to Augusta Auto Auction in addition to the winning bid, buyer's fees as posted for each bid. The total price for the accepted bid plus buyer's fees and administrative fee is subject by law to South Carolina Sales Tax. If the above terms and conditions listed on this page are satisfactory to you, please sign and date this agreement. Bids are made before a signed copy of these Rules and Regulations acknowledging the acceptance of the terms and conditions is on file together with your \$10.00, such bid may not be considered and may or may not be rejected as an incomplete bid at the sole discretion of Augusta Auto Auction.

VEHICLES DAMAGED ON THE PREMISES – Buyers and Sellers expressly release the Augusta Auto Auction, Inc., and its agents, employees and principals, from any liability for any damage done to any vehicle in the care and control of the Auction. Both Buyer and Seller acknowledge that this Auction carries no insurance on any vehicles on the premises and disclaims any liability for loss from fire, theft, acts of God, or any other causes. All vehicles are left on the Auction premises at the owner's request and risk.

LIGHT SYSTEM – Please pay attention to the lights as they are illuminated during the sale. Announcements on windows / windshields, written or posted, are a courtesy only and are not subject to arbitration.

GREEN LIGHT – Vehicles are guaranteed, by the seller, to have no single repair over \$500.00.

YELLOW LIGHT – Vehicles are sold with a caution concerning a specific announced problem.

RED LIGHT – Vehicles are sold AS IS, WHERE IS, with no guarantees except as outlined below.

BLUE LIGHT – Vehicles sold WITHOUT TITLE PRESENT. Title is attached to the seller (see title policy).

SELLERS – It is your obligation to accurately represent and guarantee the condition of any vehicle sold through this auction. If not, we offer the buyer an arbitration department to investigate and solve alleged problems. Additionally, sellers are responsible for all fees, (buy fee and sale fee), transportation expense and other expenses deemed reasonable by auction management for any vehicles returned for confirmed mandatory announcements not made.

BUYERS – It is your responsibility to become aware of all disclosures made at the time of sale before placing your bids. We will not arbitrate defects visible from the block or announced conditions. Complaints must be received by the Auction Arbitration Office within the time frames listed below.

Mileage and other information written on the window of sale vehicles or in Auction Catalogs are for the convenience of the Buyer and are not to be relied upon as accurate or complete. Buyers should satisfy themselves as to year, mileage and/or equipment by viewing the actual vehicle prior to bidding. The Auction will not arbitrate vehicles based on incorrect information written on a vehicle or in the catalog.
